

Announcement on the Amendment of the charges for personal mobile banking and internet banking services

Dear valued Customer,

Reference is made to Bank of China (Thai) Public Company Limited (the “Bank”) existing special promotion waiver of transfer fee or charge at 50% of the normal rate for personal customer as announced by the Bank. We would like to inform you that such promotion will be terminated on April 30th, 2023. The Bank will offer the new charge rates detail as shown below, which shall be applicable from May 1st, 2023 onwards. This fee rates shall be applicable until further notice.
